Please note that typically the police will not come to the accident scene or make a report if no one in the accident complains of injury. Regardless, the parties to an accident are required to exchange pertinent accident information.

Use this brochure and the accident information intake form on the inside cover to assist you in gathering the needed information from the other driver and any witness information at the time of the accident.

The right steps to take in case of an accident

• Obtain The Necessary Information

Complete this form and obtain the necessary information from the other driver and any witnesses.

• Take Photos

Keep a digital or disposable camera in your vehicle. Take photos of the accident scene and photograph the damage to the vehicles involved in this accident.

• Do Not Discuss Fault

Do not talk about the accident with anyone except to provide facts requested by the police or highway patrol at a scene. Only provide insurance, license and registration information.

• Contact Us Immediately

You have the right to recover for your injuries and damages.
